Bidh seo nas ro-innleachdail na plana na bliadhna an-uiridh agus bheir e-a-steach gníomhan a tha fhathast rin cur an gníomh cho math ri nithean ùra a bharrachd bho ISA 260 na bliadhna-sa agus gníomhan bho sgrùdadadh an luchd-obrach.

**IMPROVEMENT PLAN STEERING GROUP (IPSG)**

JG gave an update on the progress with the Improvement Plan, with the version presented having been updated since the meeting on 06/08/2020 and agreed by circulation to IPSG members. A new Improvement Plan for the coming year will be written. This will be more strategic than last year's and will incorporate any outstanding actions as well as new additions from this year's ISA 260 and actions from the staff survey.

Discussion took place regarding the appointment of external expertise in Change Management. Members agreed with the recommendation of the external auditors that the change management process should be led by an external change management expert. SML confirmed that she is pursuing appropriate expertise.

- transfer of inter-generational skills
- the value of Gaelic to Scotland's economy

Thug CH an uair sin geàrr-chunntas nas mionaidiche seachad, a' soilleireachadh raointean far an robh leasachadh air a bhith ann agus far an robh molaidhean a bharrachd airson leasachadh. B' e na raointean a chaidh a chomharrachadh airson aire a bharrachd na pròiseasan airson beachdachadh air tagraighean airson obair fo chùmhnan, a dh'fheumas sgrùdadadh dlùth gus dèanamh cinnteach gu bheilear a' cumail ri poileasaidh. Thug na buill fa-near gum bu chòir raointean-ama reusanta a chur air beulaibh ghniomhan, a' toirt aire do ghoireas luchd-obrach airson na h-obrach a tha an sàs ann am buileachadh.</p>	<p><b>EXTERNAL AUDIT</b> (<i>PK joined</i>)</p> <p><b>ISA 260 report for the Audit and Assurance Committee on the 2019/20 Audit</b></p> <p>Chair welcomed PK from Deloitte to the meeting and thanked him and the team for the thorough work done on the audit, and the assurance given in the detailed report.</p> <p>PK introduced the report on the audit, which was completed comprehensively despite the restrictions of COVID-19, giving a 'clean' audit with an unmodified audit opinion. CH then gave a more detailed briefing, highlighting areas where there had been improvement and where there were further recommendations for development. These included external expertise for change management for the organisation as a whole, and creating closer links between the proposed Medium Term Financial Plan and the Corporate Plan, to effect change and assist with implementation of recommendations in the wider scope audit.</p> <p>Members were encouraged that the audit has shown Bòrd na Gàidhlig to be in a better position than at the same time last year. Areas noted for additional attention were the processes for considering bids for contracted-out work, which requires close monitoring to ensure compliance with policy. SML referenced lessons learned and the current work to ensure that more robust systems are embedded. Training throughout the year also needs to be evaluated and reported on to assist with measuring value for money for initiatives and events. Further information from the Pension Actuaries report will be included as soon as it is received.</p> <p>The Improvement Plan will now be re-written in a more focused format and Deloitte will be involved in this process. It is envisaged that the new format will strengthen scrutiny and the monitoring of progress. It was recommended that a change management strategy and plan would overarch the Improvement Plan and have stronger ties to monitoring of the Operational and Corporate Plans. It was suggested that this would in time combine business objectives from both and create clear business pathways to implementation goals. Members noted that realistic timescales should be applied to tasks, taking staffing resource into consideration for the work involved in implementation.</p>
