2.0 **IONMHAS****FINANCE**

2.1 **Buidseat Bliadhna**
Thug NP seachad am buidseat bliadhna airson
2022/23 do na buill agus mhìnich i buidseatan
airson nan ceithir bliadhna ri teachd.

Annual Budget

NP presented members with the annual budget
for 2022/23 and outlined budgets for the
following four years.

Gus am faighear dearbhadh sgrìobhte air an
Tabhartas-gus-Cuideachadh, chan urrainnear a
bhith cinnteach dè an ìre maoineachaidh a bhios
ann airson na h-ath bhliadhna. Ach thathas a'

Until written confirmation of Grant in Aid is
confirmed, the funding level for the next year
cannot be certain. However it is assumed that
income for 22/23 will be £5.779m. This includes a

gabhaill ris gum bi teachd a-steach airson 22/23 aig £5.779m. Tha seo a' gabhaill a-steach bun-loidhne de Thabhartas-gus-Cuideachadh de £5.179m, a bharrachd air £200,000 a bharrachd airson leasachadh, £300,000 airson cosgaisean ruith agus £100,000 bho Corra airson Comunn nam Pàrant. Rinn NP mion-sgrùdadh a bharrachd air na cosgaisean sin.

Dh'fhaighnich Buill an robh e reusanta gabhaill ris nach biodh àrdachadh atmhorachd ann. Fhreagair NP gun deach cuid de dh'atmhorachd a chur an sàs, ach leis a' gainnead àrdachaidh ris a bheilear an dùil a thaobh riarachadh Tabhartas-gus-Cuideachadh, chan eilear an dùil gun atharraich mòran. Tha am plana ionmhais meadhan-ùine a' dèiligeadh ris a' bheàrn sa bhuidseit.

Chaidh innse cuideachd nach eil atharrachadh sam bith air tighinn air buidseat Riaghaltas na h-Alba, ach gum bi RnA a' coimhead airson sàbhalaidhean taobh a-staigh na bliadhna.

Chaidh innse le Stuart Pescodd, Sgioba Gàidhlig Riaghaltas na h-Alba, gu bheil an sgioba air pròiseas ùr a chruthachadh agus tron phròiseas seo bu bheil iad air coimhead air na buidseatan aca gu lèir. Tha seo air gabhaill a-steach àrdachadh ann am maoinachadh Bhòrd na Gàidhlig airson gach bliadhna, ach chan eilear cinnteach gum bi seo soirbheachail.

Mhol IMM gun tèid am buidseat seo, aon uair 's gu bheil e air aontachadh leis a' Chomataidh, chun a' Bhùird-stiùiridh mar mholadh. Dh'aontaich SML le seo, agus bheachdaich e gur dòcha gum biodh e feumail beachdachadh air a' Phlana Ionmhais Meadhan-ùine an cois a' bhuidseit.

Chaidh am buidseat aontachadh suas gu 31 Màrt 2023 agus thèid na ceithir bliadhna a leanas aontachadh fa leth.

2.2 **Plana Ionmhais Meadhan-ùine**

Thug IMM seachad sealladh farsaing agus co-theacsa air a' Phlana Ionmhais Meadhan-ùine. Chomharraich e gu bheil e cudromach coimhead air na raointean air am feum Bòrd na Gàidhlig obrachadh anns na bliadhnaichean ri teachd, gus a bhith comasach air dèanamh cinnteach gu bheil an obair a thèid a libhrigeadh a rèir dùilean. Nì seo cinnteach gun cum Bòrd na Gàidhlig smachd air mar a tha an obair aige a coileanadh nan amasan aige.

Chuir Buill taic ris a' mhodh-obrach seo agus dh'aontaich iad gu bheil e luachmhor a bhith a' dearbhadh an luach a tha Bòrd na Gàidhlig a'

baseline Grant in Aid allocation of £5.179m, as well as an additional £200,000 for development, £300,000 for running costs and £100,000 from Corra for Comunn nam Pàrant. NP gave a further breakdown of these costs.

Members asked whether it was reasonable to assume that there will not be an inflationary increase. NP responded that some inflation has been applied, but with the lack of increase expected in Grant in Aid allocation, it is not expected that much will change. The medium term financial plan addresses the gap in budget.

It was also pointed out that there has been no change to Scottish Government budget, but that SG will be looking for in-year savings.

Stuart Pescodd, Scottish Government Gaelic Team, advised that the team has created a new process and throughout this process has looked at all of their budgets. This has included uplifts in Bòrd na Gàidhlig's funding for each year, however it is not guaranteed that this will be successful.

IMM suggested that this budget, once approved by the Committee, goes to the Board as a recommendation. SML agreed with this, and considered that it may be useful to consider to Medium-term Financial Plan alongside the budget.

The budget was agreed up until 31st March 2023 and the following four years will be agreed separately.

Decision:

Members approved the budget up until 31st March 2023.

Medium-term Financial Plan

IMM gave an overview and context of the Medium-term Financial Plan. He noted that it is important to look at the areas which Bòrd na Gàidhlig has to deliver in the coming years, in order to be able to match up expectations and work delivered. This will ensure that Bòrd na Gàidhlig will be in control of how its work is delivering on its aims.

Members endorsed this approach and agreed that it is valuable to evidence the value that Bòrd na Gàidhlig is creating. Members requested clarity on

'unmet aspirations' mentioned in the plan. IMM accepted this comment.

Members asked whether it would be worth investigating alternative sources of funding outwith the Scottish Government. It was confirmed that in order to source additional funding, the organisation would need the capacity to invest time into this, which Bòrd na Gàidhlig does not have at the moment.

4.0 IONMHAS

FINANCE

4.1 Aithisg Ionmhais gu 30/11/2021

Thug NP fios air an aithisg ionmhais don Chomataidh. Tha an aithisg a' sealltainn geàrr-chunntas an dà chuid air an airgead a chaidh a ghealltainn airson na bliadhna ionmhais agus cuideachd air na pàighidhean a chaidh a dhèanamh mar thabhartasan agus ann an cosgaisean ruith. Air 30 Samhain bha £350,000 fhathast ri gealltainn, a' gabhail a-steach maoineachadh a bharrachd bho Riaghaltas na h-Alba airson oifigearan. Dùinidh tagraidhean airson an sgeama seo sa Ghearran.

Finance Statement to 30/11/2021

NP presented the finance report to the Committee. The report shows a summary of both the money that has been committed for the financial year and also the payments that have been made as grants and in running costs. At 30th November there was £350,000 yet to be committed, which includes additional funding from the Scottish Government for officers. Applications for this scheme will close in February.

Bha fo-chosgaisean cosgais-ruith air a dhèanamh suas de fo-chosgais ann an diofar roinnean caitheamh a' gabhail a-steach cosgaisean luchd-obrach.

Running cost underspends were made up of an underspend in various spend categories including staff costs.

Thathas an dùil gun tèid am buidseat leasachaidh a chosg gu h-iomlan.

It is anticipated that the development budget would be fully spent.

Dh'iarr Buill gum biodh na h-aithisgean nas ùire, thug NP comhairle gur e seo an aithisg as ùire air sgàth a' phròiseas Riaghlaidh, ach chaidh cunntas labhairteach às ùr a thoirt mun t-suidheachadh gu deireadh na Dùbhlachd.

Members requested that the reports would be more current and NP advised that due to the Governance process this was the most up to date report, however a verbal update on the position to end December was given.

4.2 Prìomhachasan is riaghailtean GLAIF 2022/23

Thug SK aithris seachad air a' phàipear agus air an sgeama taic-airgid.

GLAIF Priorities and rules 2022/23

SK referred to the paper and the funding scheme.

Mhol Buill gun rachadh coimhead air mar a bhios an sgeama air a ruith san àm ri teachd, airson coimhead air ciamar a b' urrainn do dh'obair nan oifigearan agus obair GLAIF tighinn còmhla.

Thug SK fios gu bheil beachd aca coimhead ris an sgeama nuair a thig am Plana Nàiseanta ùr a-mach agus dèanamh cinnteach gum bi a' bhuaidh as motha aige.

Dh'iarr Buill soillearachadh air na cùrsaichean bogaidh agus an deach measadh a dhèanamh orra. Chan eil seo air tachairt fhathast, ach bu chòir coimhead air seo nuair a thathar a' tighinn a-mach à Covid-19 agus siostaman ag obair nas cunbhalach na tha iad an-dràsta.

Dh'fhaighnich Buill cia mheud tidsear a tha seo a' trèanadh agus am bithear a' cumail sùil air na dreuchdan a tha ri fhaighinn do na tidsearan seo. Thug SW fios gun robh mu naoinear air a' chùrsa an-uiridh agus gun cosgadh seo eadar £40-50,000 gach neach-teagaisg. Bithear a' faighinn aithisgean bho na comhairlean agus a' cumail sùil air seo. Dhearbh SW gu bheil seo airson tidsearan 1+2.

Co-dhùnadh:

Dh'aontaich Buill ris prìomhachasan is riaghailtean GLAIF airson 2022/23.

Members suggested that the future of the scheme be looked at, to see how the work of the officers and the work of GLAIF could work together.

SK has indicated that they intend to look at the scheme when the new National Plan comes out in order to ensure the maximum impact.

Members requested clarification on the immersion courses and whether an evaluation had been carried out. This has not yet happened, but this should be considered while emerging from Covid-19 and when systems are less disrupted than at present.

Members asked how many teachers are being trained and whether the vacancies available for these teachers will be reviewed. JW reported that last year there were about nine people on the course, and this would cost between £ 40-50,000 per teacher. Reports are received from the councils and are being monitored. JW confirmed that this is for 1 + 2 teachers.

Conclusion:

Members agreed to the priorities and rules of GLAIF 2022/23.

Tha eòlaiche cuideachd air a bhith a' cur taic ris an sgioba airson dèanamh cinnteach gu bheil na siostaman ag obair cho math 's as urrainn.</p> <p><u>Co-dhùnadh:</u> Thug na Buill fa-near don sgrùdadh air Plana Gnìomh 2021/22.</p>	<p>Operational Plan 2021/22 – Monitoring SML reported that Members can see the progress of the Plan through the colour coding and is of the opinion that good progress has been made.</p> <p>Members asked whether it would be expected that greater progress would be made as we emerge from Covid. SML reported that more information had been received about working in the offices and this would mean changes for the organisation and partner organisations.</p> <p>Some of the issues in the operational plan were related to Gaelic language plans and that the team is currently very small. SML informed members that a new officer was currently being advertised and welcomed applications from those watching the live stream. An expert has also been assisting the team to ensure that the systems are working as well as possible.</p> <p><u>Conclusion:</u> Members noted the monitoring of the 2021/22 Operational Plan.</p>

Thug NP geàrr-chunntas seachad air a' phàipear. Chaidh an gluasad gu cùmhnantan fad-ùine a dhealbhadh gus taic a thoirt do na buidhnean libhrigidh sin gus barrachd luach an airgid fhaighinn agus barrachd cinnt a thoirt dhaibh.

Bheir am pasgan obrach seo cothrom do Bhòrd na Gàidhlig beachdachadh air mar a thèid iad air adhart nuair a thig na h-aontaidhean a th' ann an-dràsta gu crìch.

Dh'fhaighnich Buill a bheil cothrom ann na h-aontaidhean sin a' leudachadh do bhuidhnean eile, agus a bheil cunnart ann gum fàg gin de na buidhnean na cùmhnantan. Dhearbh NP nach bi

Members commended the fact that one Board member must have Gaelic and they raised the strong link between land and Gaelic.

Members raised that it would be good to see some Gaelic in the Gaelic Plans and they asked whether plans are available in Gaelic and English. JW replied that most are in English while they are being drafted and when they are finalised they are required to organise a Gaelic translation.

Decision:

Members approved this edition of the Gaelic Language Plan.

PT2 – Edition 02, PGR007 Angus Council 2022-2027

Members asked about the Plan Team's strategy for working with communities where there is not a large Gaelic community. JW informed members that they have been developing a more established process for plans and will be meeting with the body to reach decisions that are appropriate for different areas.

Members questioned the fact as this Council is a small area, whether links are being built between surrounding areas or other ways of supporting the plan. JW stated that this Council needs to be aware of their funding streams and officers for these objectives in their area. SML referenced Bòrd na Gàidhlig's statutory responsibility under the Gaelic Language Act to request these Gaelic language plans.

Decision:

Members approved this edition of the Gaelic Language Plan.

Impact of 3-year agreements
