Members were pleased that the universities are involved in the National Gaelic Language Plan and hoped that the University of the Highlands and Islands would be invited and the Ceannard confirmed that they had been invited

Bha ceithir molaidhean le prìomhachas iosal ann a tha a' nochdad a dhàdhais a chaidh a dhèanamh. Thug BM seachad geàrr-chunntas orra sin agus chaidh adhartas math a dhèanamh orra uile.

Board Effectiveness

BM thanked the Ceannard in particular for working so diligently with him on this report. The report is about looking forward and shows where it is expected that Bòrd na Gàidhlig is on their governance journey. Four areas of good practice were identified. BM commended the Board recruitment process used in 2020 and 2021, and the organisation's work in the online environment. BM described the work of Board members as 'sector leading' and his view that they have ensured that everything that they do is in line with the mission and aims of Bòrd na Gàidhlig.

There were four low priority recommendations which reflects the progress that has been made. BM gave an overview of these, and good progress has been made on them all.

The level of rating was discussed, and BM clarified the criteria for choosing these ratings.

Members raised a query with wording at point 3.1 about member recruitment and BM agreed that he would amend the wording if the Ceannard follows up on this with him.

Members raised that some actions could be more measurable and have clearer timescales.

Decision:

Members welcomed the report and requested that further work is done on the report.

6.2 Plana Gniomh 2022/23

An-uiridh bha am Plana Gniomh ro mhionaideach airson ire a' Bhùird-stiùiridh agus bha feum air lùghdachadh air an fhiosrachadh a thig dhan ire seo. Thug IMM fios air ciamar a thathar a' leasachadh a' phròiseis seo airson a dhèanamh nas simplidhe agus nas eifeachdaiche.

Bidh Plana Gniomh nas mionaidiche ann, le 80 gniomh na lùib an-dràsta, ri fhaighinn aig ire sgioba gniomh agus thèid sùil a' chumail air gus dèanamh cinnteach gun tèid a choileanadh/libhrigeadh.

Mhol Buill am pròiseas ùr airson dèiligeadh ris a' Phlana. Chaith bruidhinn air ciamar a thathar a' cumail sùil air adhartas agus thug IMM barrachd fios seachad air ciamar a thàinig iad dhan phròiseas seo. Thug a' Cheannard I fios gu bheil iomadh buidheann poblach ag obair gus slatan-tomhais measaидh nas fheàrr a chruthachadh.

Dh'fhaighnich Buill am bi seo mar sgrìobhainn dhà-chànanach leis gun tèid fhoillseachadh air-loidhne. Dhearbh an Ceannard gu bheil e sa Bheurla cuideachd agus gun thèid an dà chuid fhoillseachadh nuair a thèid aontachadh.

Operational Plan 2022/23

Last year the Action Plan was too detailed for Board level and there was a need to reduce the amount of information coming to this level. IMM explained how this process is being improved to make it simpler and more efficient.

A more detailed action plan, currently running to 80 actions, will be available at operational team level and will be monitored to ensure that they are achieved/delivered.

Members commended the new process for dealing with the Plan. There was a discussion on how progress is monitored and IMM provided more information on how they came to this process. The Ceannard reported that many public bodies are working to better develop measuring outcomes.

Members asked if this would be a bilingual document as it would be published online. The Ceannard confirmed that it is also in English, and both will be published when agreed.

7.0 IONMHAS

7.1 Buidseat na Bliadhna 2022/23

Tha ro-bheachdan air an dèanamh a rèir fios buidseit Riaghaltas na h-Alba air 9 Dùblachd 2021 agus a rèir a' phlana gnìomhachais a chur Bòrd na Gàidhlig a-steach an-uiridh gu Riaghaltas na h-Alba airson maoineachadh a bharrachd.

That has a' gabhail ris gur e teachd-a-steach airson 22/23 £5.779m a tha na bhun-stèidh Tabhartas-gus-Cuideachadh de £5.179m agus £200,000 a bharrachd airson Leasachadh, £300,000 airson cosgaisean ruith agus teachd a-steach eile de £100,000 bho Corra tro Chomann nam Pàrant a tha air a sgaoileadh gu buidhnean tràth-bhliadhnaichead.

Tha cosgaisean luchd-obrach a' dèanamh suas 76% de bhuidseit nan cosgaisean ruith agus a rèir comas pàigheadh air a shòn, tha iad a' co-thaobhadh ri Poileasaidh Pàighidh na Roinne Poblaich aig Riaghaltas na h-Alba. Tha am moladh poileasaidh seo airson 22/23 air a chur an sàs anns an fhigear sa bhuidseat airson cosgaisean luchd-obrach.

FINANCE

Annual Budget 2022/23

Assumptions have been informed by the Scottish Government's budget announcement on 9th December 2021 and the business plan submitted last year by Bòrd na Gàidhlig to the Scottish Government for additional allocation.

Income for 22/23 is assumed to be £5.779m which is the baseline Grant in Aid allocation of £5.179m plus an additional £200,000 for Development and £200,000 for Running costs and other income of £100,000 from Corra via Comann nam Pàrant which is distributed to early years groups.

Staffing costs comprise 76% of the running costs budget and subject to affordability, are aligned to Scottish Government's Public Sector Pay Policy. This policy proposal for 22/23 has been applied to the budgeted figure for staff costs.

Ann a bhith ag obrachadh a-mach nam buidseatan cosgais ruith a bha air fhàgail, chaidh ath-sgrùdadh a dhèanamh air an fhior chaitheamh thar an dà bhliadhna a dh'fhalbh agus far an robh e comasach chaidh ath-dhealbhadh a dhèanamh air buidseatan gus a bhith nas fhaisge air far a bheil fior chaitheamh air a bhith, mar eisimpleir lùghdachaidhean ann am buiseatan trèanaidh, siubhail agus bith-beò gus àrdachadh ann an seirbheisean co-roinnte agus cosgaisean IT a chothromachadh.

Bha dragh air buill mu bhith gabhail ri lùghdachadh sa hbuidseat trèanaidh. Dh'innis NP do bhuill gun deach am buidseat a thogail sa bhliadhna mu dheireadh airson suidheachaidhean sònraichte a cheadachadh agus gu bheil e a' tilleadh chun na h-ìre àbhaisteach aige.

Chaidh ceistean a thogail mu phròifileadh buidseit agus dhearbh NP gun tèid seo ath-sgrùdadh.

Dhearbh NP na tha a' tighinn fon bhuidseit leasachaидh mar a dh'iarr na buill.

Co-dhùnadh:

Dh'aontaich Buill ri Buidseat na Bliadhna 22/23.

In calculating the remaining running cost budgets, a review of actual spend over the last two years was undertaken and where possible there has been a reprofiling of budgets to more closely match where actual spend has been, for example reductions in the training, travel and subsistence budgets, offset increases in shared services and IT costs.

Members were concerned about accepting a reduction in the training budget. NP informed members that the budget was raised in the last year to allow for specific circumstances and is reverting back to its normal level.

Questions were raised around budget profiling and NP confirmed that this will be reviewed.

NP confirmed what comes under the development budget as requested by members.

Decision:

Members approved the Annual Budget 22/23.

7.2 Plana Ionmhais Meadhan-ùine

Bidh am Plana Ionmhais Meadhan-ùine (MTFP) seo na bhunait gus plana gniomhachais nas coileanta a chruthachadh. Mhìnich IMM mar a thèid an MTFP seo a thoirt air adhart agus dh'iarr e aonta bhon Bhòrd-stiùridh.

Dh'fhaighnich Buill an robh cosgaisean luchd-obrach gu bhith a' gluasad do raointean buidseit eile. Dhearbh IMM gum faodadh seo tachairt agus mhìnich e am pròiseas.

Dh'fhaighnich Buill mu chosgaisean luchd-obrach a' dol sìos agus chaidh a dhearbhadh gu bheil e a' tilleadh air ais chun na h-ìre àbhaistich aige. Bha còmhradh ann mu luchd-obrach taobh a-staigh Bhòrd na Gàidhlig, a' gabhail a-steach fastadh agus cunnartan taobh a-staigh an luchd-obrach. Tha e cudromach gum bi am plana feachd-obrach in-fhillte taobh a-staigh an MTFP.

'S e an ath cheum às dèidh aonta a' Bhùird-stiùridh fhaighninn, còmhraidhean a chumail le Riaghaltas na h-Alba agus an Roinn Sponsair air mar a thèid seo a ghluasad air adhart.

Co-dhùnadh:

Dh'aontaich Buill ris a' Phlana Ionmhais Meadhan-ùine mar bhunait airson plana deireannach ullachadh a thèid a thaisbeanadh don Bhòrd aig an ath choinneamh san Ògmhios.

Medium Term Financial Plan

This Medium-Term Financial Plan (MTFP) will provide a basis for developing a more comprehensive business plan. IMM explained where this MTFP will go from here and sought approval from the Board.

Members queried whether staff costs were to be allocated to other budget areas. IMM confirmed that this can happen and explained the process.

Members asked about the staff costs going down and it was confirmed that it is reverting back to its normal level. There was a discussion about staffing within Bòrd na Gàidhlig, including recruitment and risks within the workforce. It is important that the workforce plan is integrated within the MTFP.

The next steps following the agreement of Board, would be to have discussions with the Scottish Government and Sponsor Division on how to move this forward.

Decision:

Members approved the Medium-Term Financial Plan as a basis for developing a final plan which will be presented to the Board at the next meeting in June.

7.3 Maoineachadh nam Buidhnean Gàidhlig

Thug SK iomradh air a' phàipear agus na suimeannan a tha air a chur ris agus air atharrachadh.

Mhol Buill gu bheil cuid de bhuidhnean a tha a' faighinn maoineachadh bho Bhòrd na Gàidhlig a' beachdachadh air daoine neo-eisimeileach a thoirt a-staigh airson coimhead air an obair a tha iad a' dèanamh, bidh seo a' neartachadh na h-obrach a tha Bòrd na Gàidhlig a' dèanamh.

Chaidh fhaighneachd a bheil aig na buidhnean a tha a' faighinn maoineachadh bho Bòrd na Gàidhlig ri tuarastal bith-beò a thoirt dhan luchd-obrach.

Dhearbh a' Cheannard gu bheil dleastanas aig Bòrd na Gàidhlig gus dèanamh cinntach gu bheil na buidhnean libhrigidh a' cumail ri 'Cleachdaidhean Obrach Cothromach', a' gabhail a-steach tuarastal bith-beò agus tha seo anns a' chùmhant a bhios buidhnean a' faighinn.

Chaidh ceist a thogail mu dheidhinn buidhnean a tha ann an cunnart a dhol à bith agus am bu chòir dhaibh a bhith a' faighinn maoineachadh. Thug a' Cheannard fios gu bheilear a' dol a-mach gu solarachadh airson buidheann a bhios a' dèanamh lèirmheas air na cùmhantagan agus thug SK fios air na thathar a' dèanamh mus toir iad maoineachadh do bhuidhnean mar seo.

Co-dhùnadh:

Dh'aontaich Buill ris na molaidhean sa phàipear.

Grants for Gaelic Organisations

SK gave an overview of the paper and the amounts added and amended.

Members commended that some organisations receiving Bòrd na Gàidhlig funding are considering bringing in independent people to review the work they are doing, this will strengthen the work of Bòrd na Gàidhlig.

It was asked whether the organisations receiving funding from Bòrd na Gàidhlig pay staff a living wage. The Ceannard confirmed that Bòrd na Gàidhlig has a responsibility to ensure that the delivery agencies adhere to 'Fair work practices', including a living wage and that this is part of the contract that organisations receive.

It was raised about organisations that are at risk of shutting down and whether they should receive funding. The Ceannard informed members that procurement is underway for an organisation that will be reviewing the contracts and SK advised on the process undertaken before funding such organisations.

Conclusion:

Members approved the paper's recommendations.

7.4 Luchd-soidhnidh sheicichean

Thug SW geàrr-chunntas seachad air a' phàipear. Tha e a moladh plana a chruthachadh airson lèirmheas nàiseanta den Stiùireadh Reachdail le amas gun tèid an stiùireadh ùrachadh taobh a-staigh bliadhna agus gun tig am plana dhan ath choinneimh den Bhòrd-stiùiridh san Ògmhios 2022.

Mhol Buill gum bu chòir coimhead air càraichean do phàrantan agus do chloinn òg, air eagal 's gun tèid bile ùr a chur an gnìomh.

EDUCATION

Statutory Guidance for Gaelic Education

SW gave an overview of the paper. It proposes to create a plan for a national review of Statutory Guidance with a view to updating guidance within one year and presenting this plan at the next Board meeting in June 2022.
