Although there is a range of general information, there is insufficient detail around how the UNCRC will impact positively on the rights of Gaelic-speaking children and young people and their families. The reference to Article 28 and Article 2 on p8 is welcome, however Articles 28, 29, 30 and 31 as a package have the capacity to significantly impact positively on the rights of Gaelic-speaking children and young people.

Annex A

Bòrd na Gàidhlig welcomes the section on the Four General Principles and notes the confirmation on p22 that "all articles have equal status". Explanations of some of the contexts relating to direct and indirect discrimination, progressive realisation (including the statement on p27 that "a lack of resources should ...not be used by the state to justify inaction or indefinite postponement of measures to implement children's rights"), monitoring and resourcing are useful first steps in gaining an understanding of the eventual scope of the UNCRC Act.

Annex B

Bòrd na Gàidhlig notes the General Comments documents relating to Indigenous Children, Education and Leisure and Culture and looks forward to further detailed guidance on how they impact on the rights of Gaelic-speaking children and young people in Scotland. It will be important that reporting includes references to progress in implementing Articles 28,29,30 and 31 with reference to Gaelic-speaking children and young people.

Annex C

The framework provides some useful information on how to begin a process of evaluating compatibility relating to service provision. Bord na Gàidhlig notes the following:

- References to policies and "current service provision, including the absence of such provision". It will be important to build awareness around how the relevant articles are synchronised with Local Authority Gaelic Language Plans, the National Plan for Gaelic, and the requirements of the Scottish Languages Bill etc.

Children's Rights and the UNCRC in Scotland

An Introduction

Overall Bòrd na Gàidhlig welcomes the range of information provided in the Introductory Section. Bòrd na Gàidhlig is submitting following additional points:

- The UNCRC Short-Term Working Group and the Strategic Implementation Board have been noted in this section. It is unclear how Gaelic-speaking children and young people and their families have been represented in these bodies.
- Reference is made to resource spending on p6 and it would be useful to have clear guidance on resource allocation and spend to deliver on Children's Rights either in this section or in other sections.
- The minimum essential levels of rights including the provision of primary education is noted also on p6. Further comment will be made regarding this but it would be helpful from the outset to determine how the rights of children and young people to primary education through the medium of Gaelic will be delivered (Articles 28, 29, 30 and 31 are pertinent).
- Given the importance of Articles 28, 29, 30 and 31 to Gaelic-speaking children and young people and their families it will be important to publish within the Children's Rights Scheme each year how the UNCRC is delivering for Gaelic-speaking young people.
- Bòrd na Gàidhlig notes the plans for further support outlined on p14. It will be important that capacity-building support, the Children's Rights Skills and Knowledge Framework, the associated training plan and
